

TERMS AND CONDITIONS

1. Your award of the Adelphi University College of Professional and Continuing Studies Timothy Costello Award for the Fall and Spring semesters of the 2018-2019 academic year and subsequent years is made based on your fulfillment of the following requirements:
 - ◆ You are enrolled in full-time study at Adelphi University (a minimum of twelve (12) credits per semester) in a College of Professional and Continuing Studies program leading to an undergraduate degree;
 - ◆ You must continue your course of study within the College of Professional and Continuing Studies;
 - ◆ You maintain a grade-point average of **2.0** or higher each semester while enrolled in courses leading to a bachelor's degree at Adelphi University;
 - ◆ You complete a minimum of 9 credits per semester; and
 - ◆ This award can be applied to Fall and Spring semesters of study only.
2. The University reserves the right to revoke this award based on academic or behavioral violations.
3. All scholarship recipients who are **U.S. citizens or permanent residents** are encouraged to file the Free Application for Federal Student Aid (FAFSA) annually with the U.S. Department of Education regardless of expected eligibility for financial assistance. You will receive a financial assistance award notification from the Office of Student Financial Services approximately 6-8 weeks after you file the FAFSA. At that time you will also be informed of all instructions that may apply to your scholarship or other financial assistance. This award may be readjusted once your eligibility for federal, state, and other institutional aid has been determined. **Students who do not meet the eligible citizenship requirements as noted on the FAFSA are not required to file.**
4. The amount of your award is fixed and will not be increased by changes in tuition and fees that may occur, or future academic performance.
5. After filing for financial assistance, you will receive an award letter from the Office of Student Financial Services that will reflect all assistance you have been awarded.
6. This award and the amount of your award supersede any other scholarship or grant offer you may have previously received from Adelphi. After filing for financial assistance, you will receive an award letter from the Office of Student Financial Services that will reflect all assistance you have been awarded.
7. Your scholarship may only be used for tuition and fees at Adelphi University. The university reserves the right to adjust the financial assistance previously awarded when these awards in combination with other resources exceed the cost of tuition and fees, including but not limited to Veterans educational benefits, external awards, and federal and state scholarships and grants. Students enrolled in contractual programs with discounted tuition or are enrolled in online programs may be ineligible to receive Adelphi scholarships and grants.
8. Undergraduate scholarships and grants are generally awarded for full-time enrollment. The University's full-time attendance enrollment requirement may be eliminated in cases of qualifying disabilities as deemed appropriate by the Student Access Office.
